### **Academic Rules & Regulations**

- All academic sessions follow 18 Week Semester System (16 for Study+2 for Exam). Academic Calendar for each semester is made available on the notice board of AIU.
- At least 75% attendance (lectures/labs) for each course is mandatory to qualify for appearance in the final examination.
- Courses can be added and dropped only with approval of the Deans. Semester results do not show dropped courses.
- Results are based on Grade Point Average (GPA) system computed on the basis of SGPA and CGPA. The formulas of grade computation are given in the prospectus with detail.
- Students have to register for courses during the period specified before commencement of a semester. However, the Dean of a department may allow late registration on valid grounds till the end of 3rd week of a semester. A late fee of Rs. 200/- per day will be charged in such a case.
- Students may withdraw from one or more courses with approval of the Dean between the 3rd and the 10th week. Any withdrawal after the 10th week would tantamount to Failure in the particular course.

### Conduct of Students

- The AIU strives for achievement of highest standards of academic integrity and discipline as prevalent at
  institutions of high repute around the world, applying up to date measures the Student Discipline
  Committee consecutively monitors activities of each student and has been empowered to employ
  requisite procedures to maintain prescribed disciplinary standards at the university.
- Exemplary conduct is expected from the students. Their behavior should not impair or disturb the
  academic environment of the university. Any breach of discipline by a student due to involvement in
  cases such as propagating false information, theft or forgery, use of unfair means in examinations/tests,
  use of documents with an intent to deceive, failure to comply with instructions issued from time to time,
  and cases of internal disruption in teaching/research and administrative activities for any reason may
  result in Sanctions.
- Such sanctions may range from award of 'F' grade in a course to 'Rustication' or 'Expulsion' from the
  university and decision taken by the authorities in this regard will be considered 'Final'.
